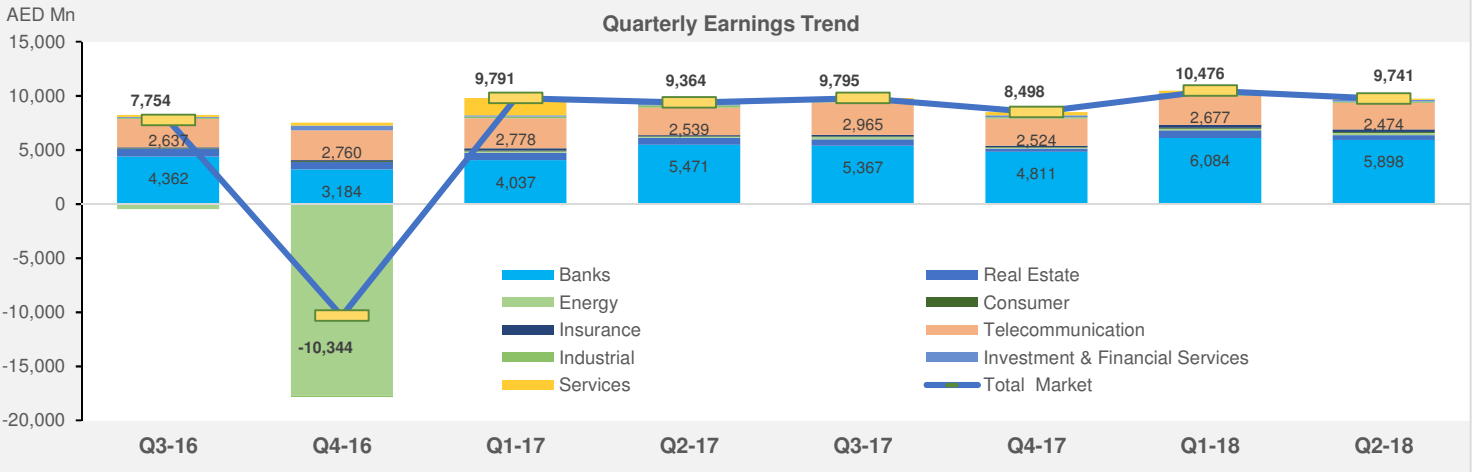
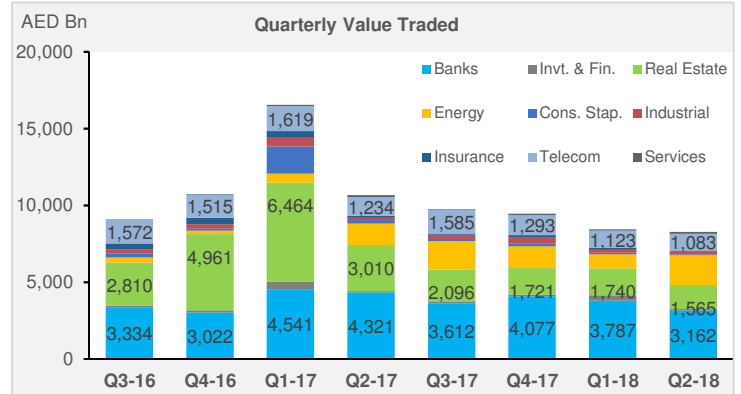
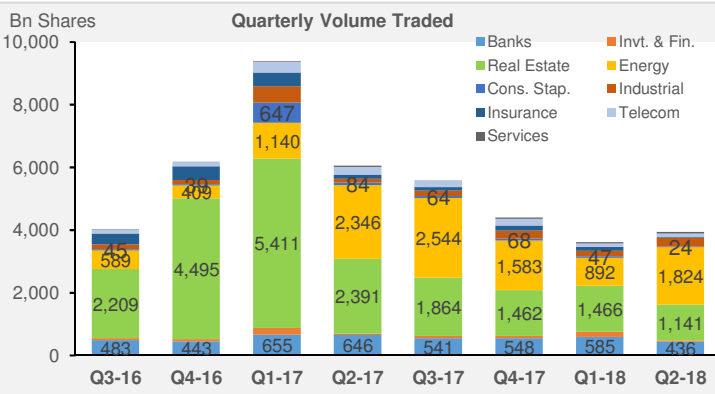
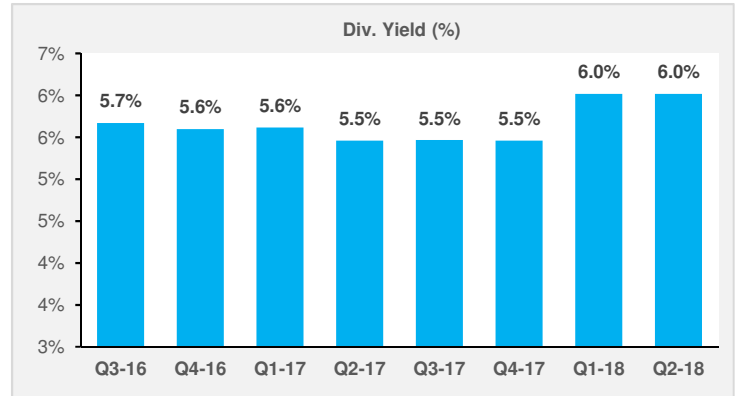
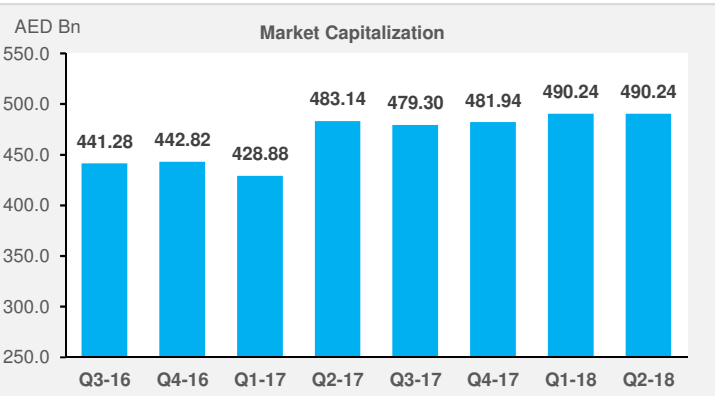
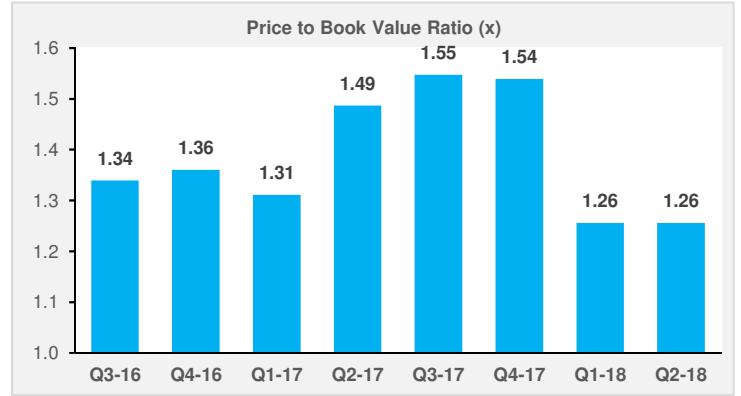
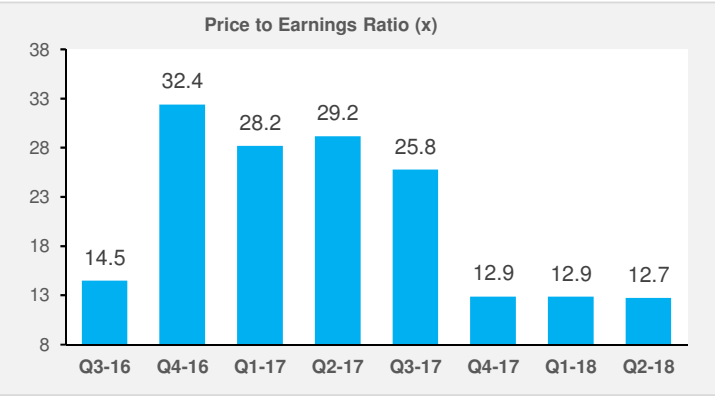


ABU DHABI (ADX) - Corporate Earnings -Q2-2018
